Whitstable Town Council Campaign

The National Association of Local Councils (NALC) showed its support to Whitstable's campaign for a new town council at the campaigns public launch on 7 June 2023.

The campaign to set up a town council in Whitstable, Kent is being led by CT5 People's Forum. The CT5 People's Forum recognised a need for a local (parish and town) council as they felt that the town was overshadowed by Canterbury City and that the city and town had different necessities. Thus, having a Whitstable Town Council would give the community a voice to make its own decisions.

NALC's chief executive, Jonathan Owen was among the speakers at the campaign launch. Other speakers included Charmaine Keatley, the chief executive of the Kent Association of Local Councils (KALC), Louise Bareham, town clerk of Faversham Town Council, and members of CT5 People's Forum.

The development of a new local council in Whitstable, aligns with NALC's longstanding constitutional objective of having England fully parish. In recent years there has been over 40 newly created local councils.

The article on the left was published by NALC, and as mentioned, KALC's Chief Executive, Charmaine Keatley, attended the launch on 7 June 2023. KALC backs campaign for a town council for Whitstable

Charmaine was a speaker at the launch of the campaign to create a Town Council for Whitstable (including Seasalter, Swalecliff and Tankerton).

The CT5 People's Forum argue nearly every urban area has a Town Council leaving Whitstable at a disadvantage.

The CT5 People's Forum have launched a petition to trigger a Community Governance Review and urge anyone who thinks the need for a Town Council for Whitstable should be investigated to sign it:

Kent Minerals and Waste Local Plan 2024-2039 -

Further proposed changes

The Kent Minerals and Waste Local Plan 2013-30 (KMWLP) was adopted in July 2016 with some limited changes adopted in September 2020 as part of the Early Partial Review. A Kent Mineral Sites Plan which allocates three areas of land suitable for development associated with the extraction of sands and gravel was also adopted in 2020. Together these documents form part of the Development Plan which represents the planning policy framework for minerals and waste development in Kent.

We are inviting comments on the further proposed changes which are set out in the draft Kent Minerals and Waste Local Plan 2024-39 - Further proposed changes document.

There are three areas of the Local Plan which are proposed for further changes. These are summarised as follows:

- 1. Changes to Policy CSM 2, and associated supporting text, relating to the quantity of aggregate mineral to be planned for
- 2.Deletion of Policy CSW 5 that allocates land for an extension to Norwood Quarry, Isle of Sheppey for subsequent filling with hazardous flue ash
- 3.Deletion of paragraph 6.3.3 (and associated sub-title) which concerns making specific provision within Kent for the management of residual non-hazardous waste by landfill or energy recovery that arises in London

The consultation is now open and will close on 25 July 2023.

Unlike social media, My Community Voice is a secure and personal messaging system that allows you to determine what type of alerts you receive and how.

KENT FIRE AND RESCUE SERVICE "SAFE AND WELL" VISITS - WELL WORTH IT!

I contacted Kent Fire and Rescue Service (KFRS) recently to see if our family was eligible for a Home Fire Safety Visit. We have just moved to a new property that suits the needs of my wheelchair user husband, and I was very keen that our new home was safe and secure from any potential fire risks.

Our circumstances meant that we were eligible for the service, and we were duly booked in for a visit. We had Ru come to our home and he was brilliant! His cheery and professional disposition really helped matters along. He did a thorough check of our appliances and made sure there was no reported "recalls" on any of our White Goods and made sure that as a family we had a good plan in place for an evacuation if a fire should arise.

Likewise, he checked that we knew what a potential hazard was and what we might want to change to avoid them. We were provided with new smoke alarms, which were expertly fitted by Ru, and left with leaflets for any further help we might need. In short, if someone in your community is eligible for such a visit, encourage them to take it up. It won't last longer than around an hour and may well save you from a fire in the future.

Chart Sutton residents are still talking about the hugely successful Coronation Party that the

Parish Council managed to arrange at short notice and with limited funding. The council was fortunate to attract Lottery Community Funding, and local donations along with local people giving their support and time to make it happen. Some 20 plus residents came forward to help in February and 20 plus people helped put up and take down the bunting. The party attracted 200 residents and they were treated to a big barbeque. An ABBA Tribute band, plus music from local talent, donated strawberries and a souvenir bag all added up to five hours of fun!





Edenbridge Town Council celebrated in style on Sunday 7 May with a Big Coronation Lunch to mark the Coronation of King Charles III and Queen Camilla. The local community was invited to come along to the Recreation Ground from 1-7pm for free live music, entertainment and children's activities. There was also a crown competition as well as a royal quiz and prizes for the best dress -up! Lots of people set up for the day and enjoyed picnics and food from the several food trucks and stalls.



High Halden held a Coronation event on Monday 8 May on the village green. The event was packed and attendees were entertained with a dog show, live dancing, live band and lots of stands. Tea, coffee and delicious cakes were donated and served by the Parish Council. High Halden has a village events committee and most Councillors sit on this committee. A scarecrow competition was organised and residents erected scarecrows of Charles and/or Camila in their front gardens. The results were announced at the fete and the winning scarecrows were displayed.

YOUR CORONATION CELEBRATIONS!

Capel-le-Ferne Parish Council, and other community bodies in the village, hosted an event on Sunday 7 May 2023in the Village Hall to celebrate King Charles III Coronation. 200 Members of the Community attended.

Refreshments were served in the Village Hall, the Women's Institute made a Coronation Cake and the Kent Police Cadets attended to give assistance with an inflatable pirate ship.

The addition of a plaque and dedication were completed in the presence of the school children who sang the National Anthem in honour of the late Queen.

From community groups to schools and universities, local councils to libraries and theatres, City of Sanctuary works with individuals, groups, and organisations in every area and in every sector to encourage inclusivity, solidarity, and compassion for people from a forced displacement background. The Sanctuary Awards programme recognises and celebrates the organisations and institutions going above and beyond to create welcome, compassion and empowering opportunities for people seeking sanctuary. The City of Sanctuary Local Authority Network is a movement of local councils who are working to create a culture of welcome, inclusion and empowerment for people seeking sanctuary. City of Sanctuary status is normally accredited to principal councils e.g., Districts and County Councils.



Sevenoaks Town Council and Sevenoaks Welcomes Refugees is delighted to have been accredited with the first Town of Sanctuary award for the town of Sevenoaks.

"I am delighted that Sevenoaks has been recognised by the City of Sanctuary programme. Through Sevenoaks Welcomes Refugees and through the individual actions of Sevenoaks people opening their homes and lending their time and skills, I believe we extend a warm welcome to those who arrive here in very difficult circumstances. Everyone living in Kent has felt the reality of climate change, with increasingly hot summers, hosepipe bans, high winds, extreme rainfall and flooding. In 2022 West Malling Parish Council declared a Climate Emergency, following the lead of the UK government, Kent County Council and Tonbridge and Malling Borough Council

By declaring an emergency WMPC acknowledged the urgent need to act on the causes and impacts of climate change, and committed to:

- · Establishing a Climate Change and Biodiversity Action Group.
- · Mapping WMPC's carbon footprint using the tool developed by KALC. (LINK?)
- · Working towards making WMPC activities net-zero carbon by 2030.
- · Achieving 100% clean energy use for all activities as soon as possible.
- · Embedding climate emergency considerations in all work areas and decision-making.
- · Reviewing the Local Plan / Neighbourhood Plan ensuring it is "green to the core".

Once established the CC & BAG wrote an environmental policy

setting out the following aims for WMPC:

- to promote the value of a quality environment and support residents to enjoy it.
- to work towards environmental sustainability, i.e. protecting and enhancing natural assets e.g. access to green space, local biodiversity, and air quality.
- to work efficiently and minimise adverse impact on our environment.
- to promote the development of a circular economy (minimising waste through sharing, reusing, repairing and recycling).

After a year...

We have measured our carbon footprint. In the year 2021-2022 the direct activities of WMPC emitted 8.9 tonnes of CO2. 76.41% came from the electricity we use to light the streetlamps.

- We have written to contractors asking them for information on fossil fuel use so that we can calculate the impact of our wider activities eg hedge cutting.
- We have investigated possibilities for installing Electric Vehicle Charging points on WMPC land and applied for a grant for two EV chargers at the Village Hall.
- We held a 'Greener West Malling'
 event. A public meeting bringing
 together local green initiatives
 including speakers from
 Communigrow, Kent Wildlife Trust
 'Wild about Gardens' project, the
 Repair Café, the Kings Hill Refill Hub,
 and a local resident who had
 invested in reducing the carbon
 footprint of her home.

The future...

We are urgently looking at switching to 100% renewable energy.
We plan to widen the scope of our measurement of the WMPC carbon footprint to include the indirect impact of PC activities through contractors.

We want to measure the carbon storage available to WMPC (eg the heritage orchard and the cricket pitch) to offset against unavoidable emissions. We also want to achieve maximum ecological benefit from managing these assets. We want to focus on reducing the use of poisons on WMPC land.

The planning committee intends to engage with e.g Historic England to look for ways to make restrictions on listed buildings compatible with comfortable, affordable, modern living.


We want to engage with the community.

D DAY COMMEMORATIONS 2024



The 80th year
Commemorations of D Day, or
Operation Overload, will take
place on 6 June 2024. This will
be a momentous occasion for
many reasons and so parishes
and towns are being
encouraged to mark it in a
suitable way.

Operations Overlord and Neptune are now considered to be the most audacious campaigns of the Second World War. They made way for the liberation of mainland Europe and set the wheels in motion for VE Day in May 1945.
